NOTICE

Required It shall be unlawful to set up or operate a carnival within the boundaries of the city without obtaining an amusement permit issued by the city.

Permit Dates; Duration Permit dates will be granted on a first come, first served basis. No permits shall have an effective date for a period of more than five consecutive days. No consecutive amusement permits shall be granted for less than a 35-calendar day interval.

Time Period An amusement permit shall not be issued for a time period less than ten days nor more than thirteen months from the date of the application submittal.

Location An amusement permit will be issued only in the C-2, M-1, and M-2 zoning districts or any public park, or land controlled by any taxing entity.

Application Requirements All amusement permit applicants shall provide necessary documents, including certificate of insurance, safety inspection reports, and certificates issued by the state board of insurance granting the applicant the authority to operate legally in the state.

Information On Preceding Venues All first-time amusement permit applicants that have no history established with the city shall provide contact information for the three immediately preceding venues where the carnival has operated.

Inspections All carnivals operating under an amusement permit issued by the city shall be subject to periodic inspections, [for] public safety concerns, at the discretion of the city as authorized by the regulating authority.

Application Fee A nonrefundable application fee in the amount of \$100.00 shall be submitted with each amusement permit application.

Administrator The Inspector's office shall be the designated administrator of this article.

Penalty Persons found guilty of violating the provisions of this article shall be subject to the penalties and fines allowed under a class C misdemeanor.

I, the company principal, do hereby state that all the information supplied with this application is true and correct. I also understand my facility may be subject to inspection at the discretion of the City of Snyder under the provisions of Ordinance 1003. In the event any information provided on this application is false, the permit will be immediately nullified, as well as the application fee.

Inspections are to be requested as needed during work.

I understand that all permits require a final inspection.
