Work may not start until a permit has been issued pursuant to approval of this application. Permits so issued shall not be construed as authority to alter or set aside any building and/or plumbing code requirement, nor shall such issuance of a permit prevent the Building Official from therefore requiring correction of errors in plans or in construction, or of violations of building codes or ordinances. By signing, you understand the limitations to the permit listed and possible requirement to remove work if non-compliant.

Permit shall become invalid if work is not commenced within six (6) months after issuance, or work authorized by such permit is suspended or abandoned for a period of six (6) months or longer after work has commenced.

Inspections are to be requested as needed during work.

**I understand that all permits require a final inspection.**
